3. As soon as we receive your order and deposit, we will contact you to provide an estimated delivery date to the processor. Normally delivery to the processor takes 60-120 days.
4. We will pick the processor based on first availability, however, if customer wants organic processing or if customer wants to select a specific processor in the area, please let us know and we will try to accommodate the request.
5. Once the date is scheduled for delivery to the processor, customer must complete a Cut Sheet and send it to contact@mountairyfarms.com prior to the delivery date.
6. Upon delivery to the processor, we will send you a final invoice which is due within 5 days of receipt. MountAiry Farms must receive full payment in order for you to pick up your meat from the processor.
7. The processor fees are paid by customer directly to the processor at the time you pick up your meat. The processing fees for a half steer are estimated to be approx. \$175-275.
8. Customer acknowledges Mount Airy Farms has no control over the processing of the livestock including, the cutting, packaging, or storing of the meat. Therefore, Customer hereby agrees to hold harmless Mount Airy Farms and its related entities, agents, employees, and representatives from any and all claims related to the sale of the livestock once the livestock is delivered to the processor.
